Why water purification is important?

Water purification, today is essential due to the presence of vivid and harmful contaminants present in the water supply. Rapid urbanisation and speedy industrial growth have led to significant pollutants and contaminants being found in the water supply. This is a list of some of the harmful contaminants found today in the water supply which if consumed in excess can be detrimental to human health.

- TDS (Total Dissolved Solids).
- VOC (Volatile Organic Compounds).
- Heavy metals like Iron, Mercury, Arsenic, Copper, Lead etc, Pesticides, Imbalanced pH.
- Microorganisms such as pathogenic bacteria, virus, protozoa and cysts.

KNL Healthy Drops water purifier has designed total 6 models considering the valuable recommendations of WHO, BIS, EPA and other medical recommendations. We have categorizes the water in five main categories. 1) Extremely soft water having TDS less than 150 PPM, 2) Soft water having TDS range between 150 ppm to 350 ppm, 3) Moderate hard water having TDS range between 300 ppm to 650 ppm, 4) hard water having TDS range between 650 ppm to 1400 ppm and 5) extremely hard water having TDS range between 1400 ppm to 3000 ppm. According to these five categories we use suitable technologies in water purification process so that the drinking water must contain necessary minerals, pH (low alkaline) and must be free from germs, bacteria, virus and other harmful impurities. In our technology 100% water is being passed through NF/RO membrane to ensure germs free drinking water.

How does KNL Healthy Drops water purifier work?

Stage 1 - Pre-filter

(P.P Spun filter 10") - is used to capture particles (clay, sand, dust, rust, color etc.) those remain in size of 5 micron or above in supplied water and then goes to sediment filter.

Stage 2 - Sediment filter

(5 micron absolute) - the filter made from Polypropylene & wound string both end sealed caped. Polypropylene is resistant to the growth of bacteria. The filter captures suspended matter such as sand, silt, loose scale, clay and organic material from the water and supplies clean water carbon block filter and NF/RO membrane for further purification.

Stage 3 - Activated Carbon block filter

Activated carbon block filter absorbs harmful chemicals, pesticides, excess iodine, chlorine etc from water up to 99.9% and removes odor, smell and enhances water taste. Due to high absorption rate of chlorine and iodine, the TFC membrane life increases and gives best result.

Stage 4 - UV Chamber & UF Membrane 8"

(pore size 0.1 micron) - used to pass the water through UF and SS UV Chamber (SS 304-high density material is used for better performance) to kill germs, bacteria and virus and this stage is applicable in KNL-UVUF-AR only for the rest.

NF40/NF60/RO Membrane (pore size 0.001 micron, 0.0005 micron and 0.0001 micron respectively) used to eliminate all harmful water born germs, bacteria, virus, chlorine, pesticides, herbicides, harmful chemicals like arsenic, bromide, fluoride etc from drinking water and all those harmful materials being flushed through rejected water. Please note water molecule size is 0.000283 micron, whereas water born bacteria/virus size remain 0.01 micron to 5 micron and therefore being eliminated through the membrane and flushed them through rejected water with great success.


Stage 5 - AAA Filter

(Antibacterial, Alkaline and Anitoxidant) - is used to add/enhance pH (alkalinity) and essential minerals in drinking water. We use regulator to regulate the pH value of drinking water between 7.2 pH to 8 pH which is ideal and in best condition for human consumption.

Stage 6 - Post Carbon Block Filter

(Coconut shell compressed fine carbon) - water passed through the post carbon block filter which is made from coconut shell compressed fine carbon and then goes in blue transparent storage tank of the purifier. As we know the coconut is antibacterial agent and therefore it inhibits the growth of microbes and removes smell, odor and enhances the drinking water taste too.

KNL Healthy Drops water flow diagram:



Installation guidlines:

- 1. The water purifier must be installed in shade area, protect from direct sunlight, rain and hot water above 40 degree Celsius
- 2. The waste water tube must be kept lower than the water purifier else it will create extra back pressure inside the inline filters and booster pump and will harm machine and water quality too.
- 3. Pre Filter must be installed within 1-3 feet of distance from the water purifier in parallel line or may be above the purifier suitably but must not be installed lower than the level of the purifier machine.
- 4. The purified water after the membrane is diverted in two directions using two control valves to regulate the flow of purified water that passes through Post carbon block filter and AAA filter. The two regulators are used to adjust the pH value & minerals in drinking water. The ideal pH value is recommended between pH 7.2 to pH 8. More than pH 8, the drinking water becomes more alkaline which is not good for health in long run.
- 5. There must be space above of the water purifier of at least 1 ft so that the head cover can be operated comfortably

User guidlines:

- Avoid feeding dirty/cloudy water suply else it will colg Pre-filter early. Pre-filter is not covered under warranty/guarantee. If raw water is clean/crystal clear transparent, the ususal life of the pre filter is 4 to 5 months. It is recommended to change the filter periodically.
- 2. Keep always clean and hygeine around the water purifier
- 3. The effective life of the inline filters including membrane is around 10,000/- liters or 12 months whichever is earlier and accordingly get the service done of your water purifier.

Terms and Conditions of warranty

KNL Trading Co. warrants all new products manufactured/assembled by it to be free from defects in material and workmanship under normal usage and service from the date of purchase as under:

- 1. The Warranty period commences from the date of installation by the first end-user. During this Warranty period of one year, KNL Purifiers or its Authorised Service Provider (ASP) will replace or repair any part of KNL Purifiers, that in the opinion of KNL Purifiers or its ASP, would be defective in operation due to faulty material or workmanship (i.e. manufacturing defects) with the exception of consumables such as Sediment Filter, Carbon Filter and RO/UF Membrane. However, if the RO/NF/UF Membrane and/or if the inline filter/s gets clogged within first six months, they shall be cleaned / repaired / replaced at no extra charge.
- The product's plastic body is not covered under Warranty and hence, it must be handled with care to guard against breakage/scratches.
- The original purchaser of the unit can avail services under Warranty at the point of sale, by producing the damaged part(s) along with the original invoice.
- This Warranty is void if the unit is not operated under normal water turbidity conditions (must be between 1 ntu to 2 ntu). Above 2 ntu water becomes visibily dirty.
- Product returned to KNL Purifiers or its ASP for Warranty examination must be shipped freight prepaid.
- KNL Purifiers or its ASP shall not be held liable for claims exceeding the cost of repair of the defects in workmanship.
- This Warranty Agreement shall not be interpreted to render KNL Purifiers or its ASP liable for injuries or damages of any kind -direct, consequential or contingent to persons or property.
- 8.
